FEES: \$7.00 for the 1st entry of a dog, and \$5.00 for the second entry of the same dog; \$2.00 for Showmanship (junior and adult).

GENERAL COMMENTS: Dogs with majors or titles may be shown for exhibit only; no more than two entries per dog; poodles in show trim; no ear tape; AKC regulations; ribbons & rosettes, refreshments available. Professional handlers may only show dogs owned by themselves.
